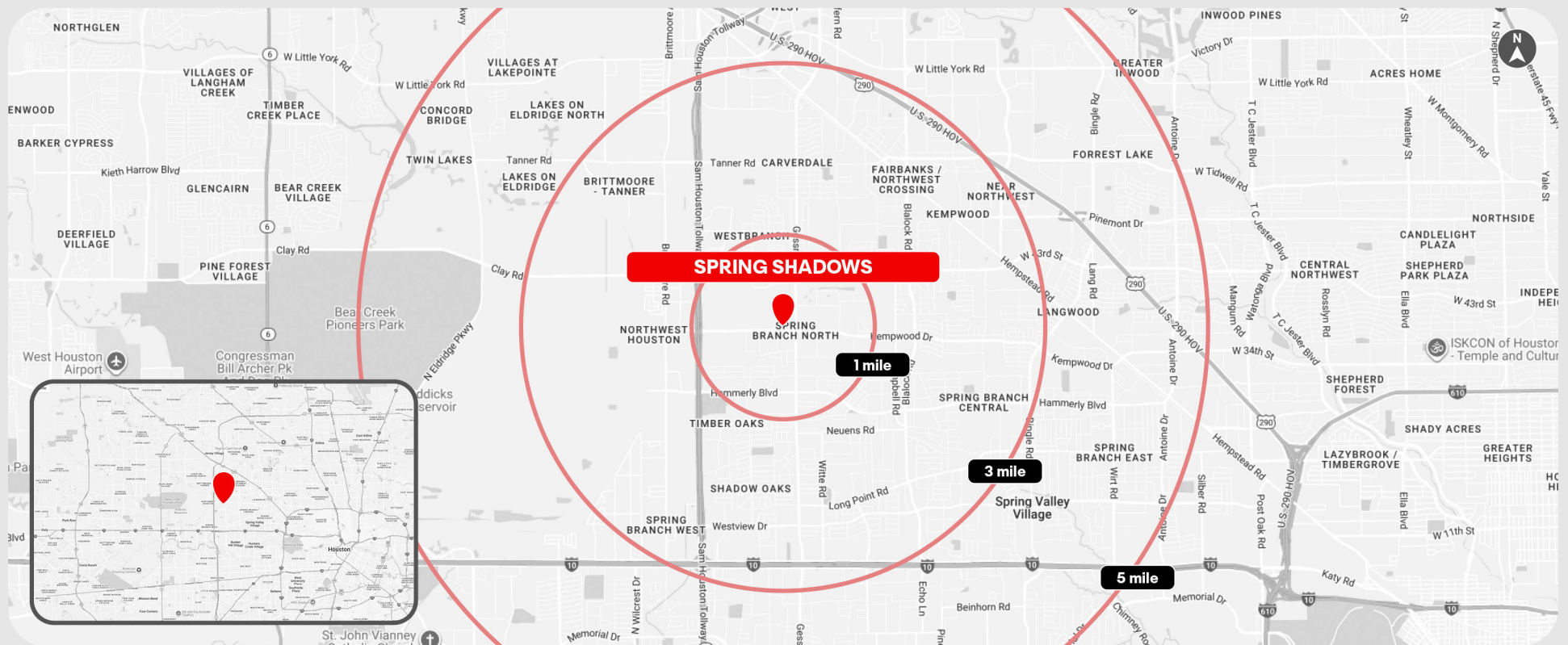

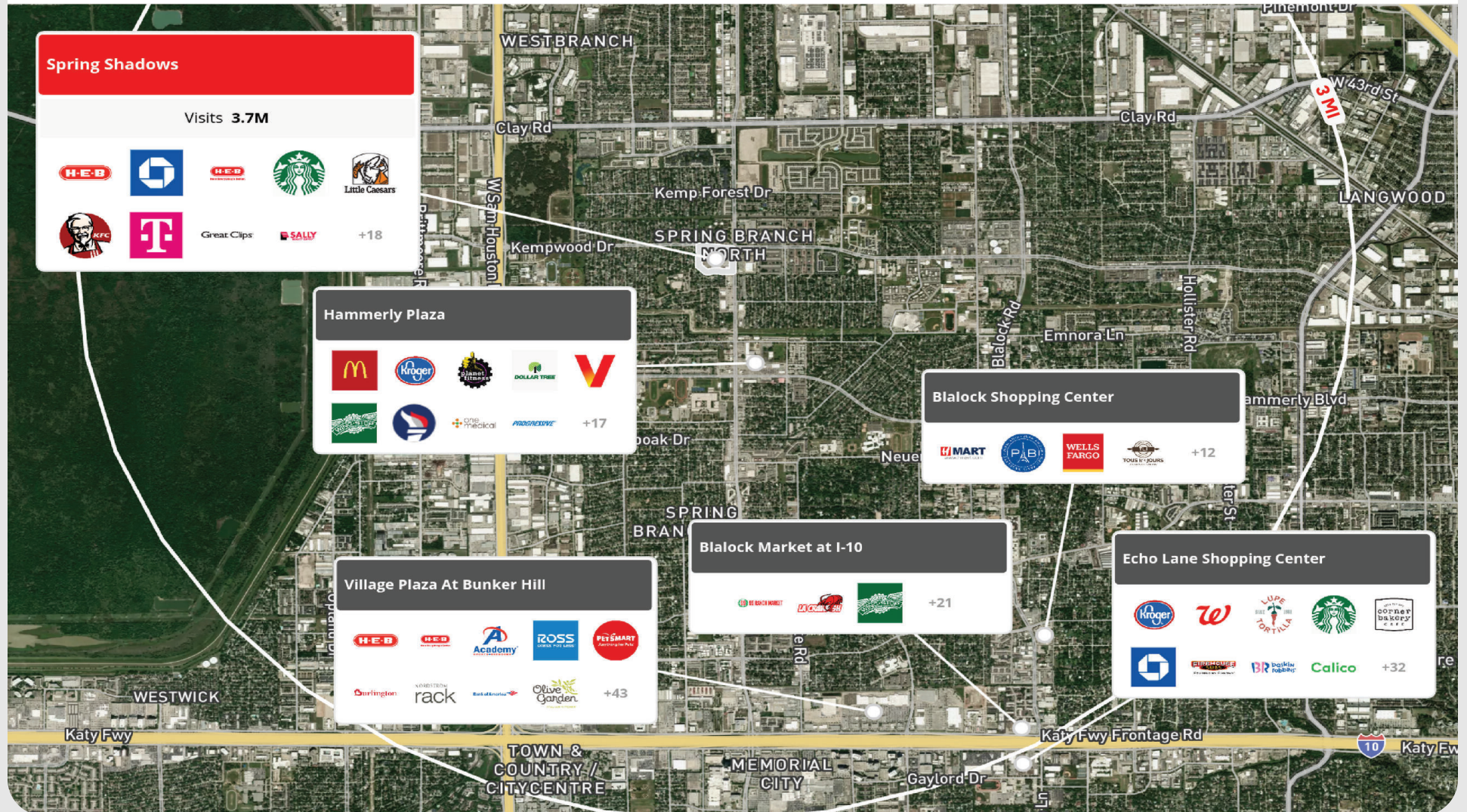

Market Aerial

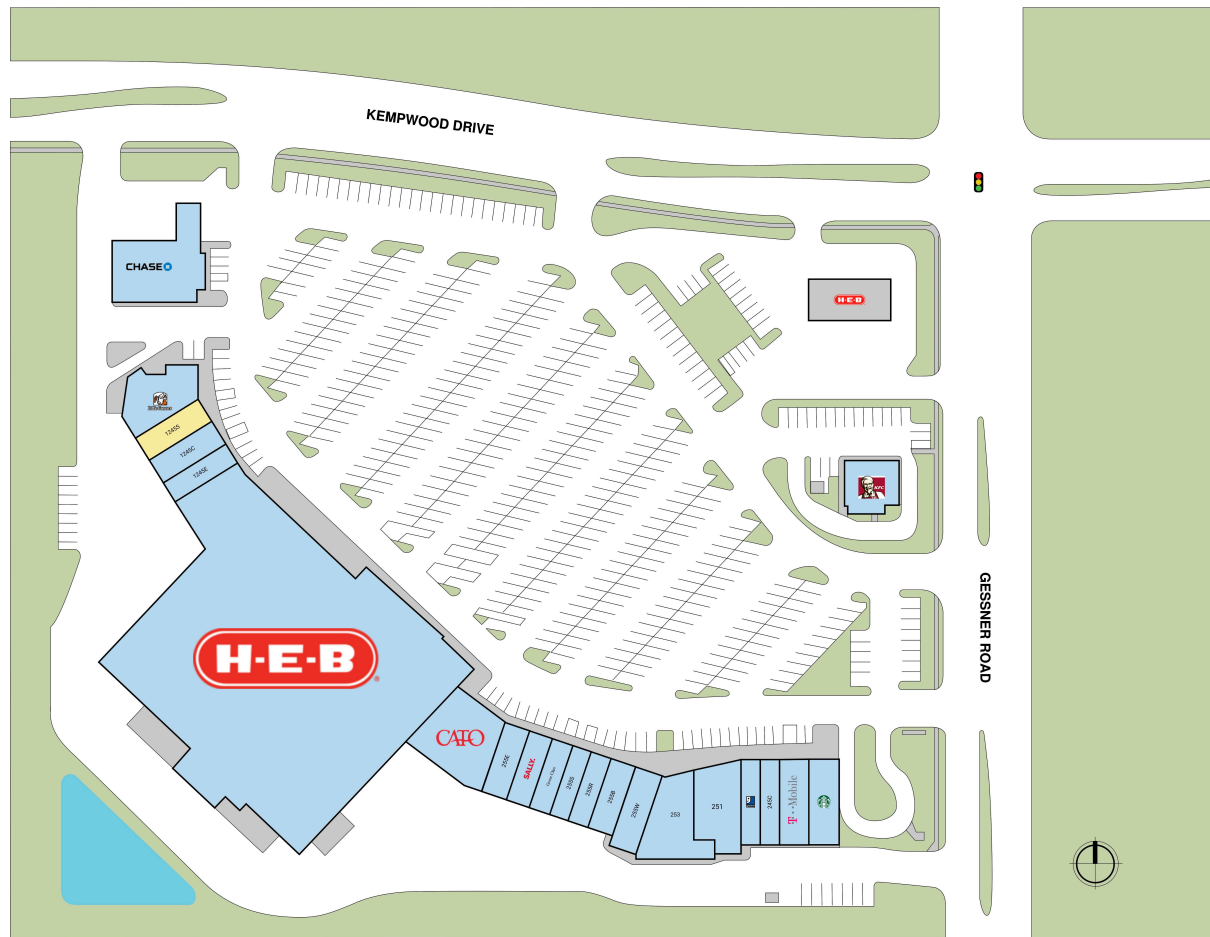
